3) Business Arising from the Previous Minutes of January 9, 2023.

4) Public Question Period.

There were no questions from the public.

5) Government Appointees (Second Mandate)

Don Shewan explained that several Government Appointed members, those being: Moira Paterson, Jean-Robert Lessard, Geneviève Bourgoing and Michael Newton are eligible to serve a second mandate should they wish. All have accepted and we are only awaiting official paperwork from one member. Dawn Smith and Jaswinder Sehota will remain until a replacement, provided by the government for them, has been found.

Student Representative mandates will also come to an end this year. Juliana Varin, VP of external Affairs for the next academic year, who will be replacing Joao Amorim was introduced and was welcomed by all. The replacement for Rafin Islam will be most likely attending the next meeting as well.

At the New Student and Parent Information evenings held at the College on May 2nd and 3rd, Don Shewan was able to collect email addresses from about fifteen parents expressing interest in sitting on the CCSL Governing Board. We hope to have a new parent representative for next year to replace Louis Zargi who has been kind enough to extend his mandate in the meanwhile.

6) Academic Calendar 2023-2024 Resolution No.: LAM-2022-009

Don Shewan spoke to this item explaining that the Spring Reading Week is now aligned with the Riverside Schoolboard calendar.

7) Access to surplus finds for Faculty Release Time regarding Law 14 Resolution No.: LAM-2022-010

Don Shewan spoke to this item.

WHEREAS the new language law (Law 14, formerly known as Bill 96) has imposed additional requirements on the College for the development of both French courses and courses in French; and

WHEREAS the current resources provided by the government are insufficient to fully meet these challenges which will directly impact the success of our students;

BE IT THEREFORE RESOLVED that the Champlain College Saint-Lambert Governing recommend the Board of Governors approve the access to the Saint-Lambert portion of the college's accumulated surplus in the amount of \$200,000 to develop courses and support activities to address these challenges.
